## NEW CHANGE TO THE NWSA CONSTITUTION AND BYLAWS

(Revised at the Pensacola Reunion 30 April 2014)

ARTICLE V - OFFICERS

Section 2. Terms of Office

The officers of the NWSA shall serve for a term of two years. The President, 1st Vice President and 2nd Vice President will alternate years with the Secretary/Treasurer so there will be continuity in the organization. Officers Elect will be installed at the appropriate reunion banquet.

#### a. No Change

How this will work:

The President Elect for 2014 will serve a one-year term. The two year term for the President, 1st Vice President, and 2nd Vice President will be affective in 2015. Their term will expire in 2017. The Secretary/Treasurer elected in 2014 will serve a two year term, expiring in 2016, thereby having the election of the President and Secretary/Treasurer's offices expire in alternate years.

#### **Snooping on the Russians**

.After returning to the U.S. from a year in Vietnam, I took command of the USS Holder (DD-819) home ported in Norfolk, VA. I relieved the old commanding officer on a Saturday and on Tuesday we were enroute to Gitmo for 6 weeks. Following Gitmo, the ship joined a carrier task force group (one carrier, one supply ship, a submarine, and six destroyers) for a 6 month Med deployment. Just before departing Norfolk, the Holder was selected to receive a CONEX full of special electronics for snooping on Russian ships and eight highly trained intelligence personnel.

After about a month in the Med, the Holder was scheduled for five days liberty in Mallorca, Spain. We were "Med moored" (anchor out forward, stern tied to pier) in the inner harbor; the crew was enjoying liberty in Spain. About 3 hours after mooring I got a message from the task group commander to get underway in 3 hours, message to follow. We got about 80 to 90% of the liberty party back onboard and were underway heading south for the north coast of Algeria.

A Russian sub had a fire onboard and could not submerge. The sub was being was being escorted by a Russian Kresta (cruiser) for repairs in the Black Sea Russian shipyard. The U.S. Navy had been trying to collect intelligence on Russian submarine communications and this seemed like a golden opportunity.

A day and a half later we found them hiding in among some merchant ships heading west toward the Black Sea. The Kresta stayed about 1000 yards on the beam of the sub, so I just snuggled my destroyer between them, all heading west at about 4 kts. The Kresta didn't like this at all. She frequently tried to ram us. But she was much bigger than the Holder and therefore the

cruiser had a turning circle that was larger than ours, so when she would turn toward us we would snuggle up to her port or starboard quarter and turn with her. We did this for about four days and nights. The special box and its people collected some good intelligence on Russian communications.

After the fourth day, we got a message from the task group commander that there were three Russian frigates heading our way and we were to back off the surveillance and return to the task force group ASAP.

## Navy Announces Decision to Base the F-35C at NAS Lemoore

NORFOLK, Va. (NNS) -- The Department of the Navy, after carefully weighing the strategic, operational, and environmental consequences of the proposed action, has decided to base the F-35C aircraft at Naval Air Station (NAS) Lemoore, California.

This will be accomplished by implementing Alternative 2 of the Final Environmental Impact Statement (EIS) for U.S. Navy F-35C West Coast Homebasing.

Under Alternative 2, a total of 100 F-35C aircraft in seven Navy Pacific Fleet squadrons (10 aircraft per squadron) and the Fleet Replacement Squadron (FRS) (30 aircraft) will be based at NAS Lemoore beginning in 2016. The proposed action will be completed in the 2028 timeframe. The Navy has determined Alternative 2 best meets the operational needs of the Navy and, where feasible, minimizes potential environmental impacts.

The 100 F-35C aircraft will replace 70 aging FA-18 Hornet aircraft. As a result, aircraft based at NAS Lemoore will gradually increase by a total of 30 aircraft by 2028. Although this action calls for an increase of 30 aircraft based at NAS Lemoore, the FA-18C FRS with 30 aircraft assigned was disestablished in 2013. When the FRS for the F-35C is operational (in about 2018), the number of aircraft based at NAS Lemoore will be similar to 2013 levels. There will be no changes in aircraft


based at Naval Air Facility (NAF) El Centro, California, under Alternative 2. Basing the F-35C at NAS Lemoore will result in an increase of about 68,400 operations per year at NAS Lemoore and an increase of about 800 operations per year at NAF El Centro.

# Snowpocolypse, Not Polar Vortex, Winter Weather By The End of Sept 2014 Through June



SILVER SPRING, Maryland -

Chances are you will hear a lot about El Niño in the next month or two. Meteorologists and weather science experts at the National Weather Service (NWS) say that there is a 99% chance that the we will start to see a massive cold-front sooner in the year than has ever happened, which will produce not just record-breaking snowfall, but according to Dr. Boris Scvediok, a doctor of global weather sciences, record shattering snow storms across the board, affecting the entire United States.

"For the sake of comparison to the past winter, let's say that your area received a total of twenty inches of accumulative snow for the season. Because this year the snowfall is predicted to start by the end of September or the beginning of October, you can expect to multiply that number by up to five, ten, maybe even twenty times in some areas. In the worst zones, you could see 50 times the amount of snow you've had in the past. This is the type of winter the American public needs to prepare for. Several meteorologists are saying not to buy into what the models are showing. I can tell you from forty years of scientific weather research, they are doing you a disservice," Dr. Scvediok told the Associated Press on Friday. "The Northeast, Ohio Valley, and Midwestern states will definitely get hit the hardest."

Edward F. Blankenbaker, Senior Administrator of Meteorologists, also told the media that this will be an once-in-a-lifetime kind of snowy winter.

"Pretty much everyone will see snow like they never have in their lives. Most younger people don't even know what an actual blizzard looks like, but by the end of March, they will be seasoned survivalists," Blankenbaker said. "Everyone needs to make sure they have their weather emergency kits prepared and ready to go. There will undoubtably be mass power

outages, which along with freezing temperatures and enough snowfall to immobilize entire cities, will most likely, and unfortunately, be a very dangerous recipe. Safety always comes first and the time to prepare is right now."

Along with the mention of severe winter weather, the Food and Drug Administration (FDA) predicts supply and demand could cause shortages, causing the prices of bread and milk to increase substantially. FDA spokesperson Rebecca Miller suggests alternatives in preparation of the coming months.

"We are encouraging that you go out and purchase bulk amounts of dry, powdered milk which can be stored in your cupboards. This will prevent frantic trips to grocery stores and super markets as the onslaught of storms begin to fall upon your respected region." Miller said. "As far as bread, we suggest you buy as much as you can efficiently store in your freezer. Bread can be frozen and thawed without compromising the integrity of its quality. Preparations such as these are crucial and the fact that technology has brought us to a time and place in which such events can be predicted is guite remarkable. So stock up on your powdered milk and fill your freezer with loaves of bread, because once the blankets of snow begin to fall, brave souls will confront the elements to raid stores of these products like some sort of scavenger hunt. Don't be a part of the Snowpocolypse, it's a dangerous battlefield of crazed shopping winter bitten weather zombies."

Public safety organizations also encourage the masses to prepare themselves by obtaining proper necessities. James Satterfield from the National Fire and Safety Advisory Board says preparation can save lives. "Don't wait until temperatures plummet into a freeze; obtain cold weather clothing and footwear, including wool thermal socks. It is also crucial to have plenty of batteries, candles, weather radios, you name it. Get prepared, it's coming." Satterfield stated. "First and foremost, make sure you have an effective plan in place to make sure you have plenty of bread and milk."

Dr. Scvediok says to be prepared for a storm that could come as early as the end of September, and plan for the entire winter season, which this year, he says, will more than likely spread into next June.

#### Travel via the Moon

Travel around Europe can take many different modes from rental cars, to buses, trains, and as many find interesting, chartered tours with tour-guides on tour buses.....you'll hit small towns and unknown locations to large cities and famous locations there, and certainly, a great way to see much of those areas you heard about....and of course, you did study on what you hope to see thru your local bookstore books about that country/city you're planning to visit. But if you've never tried it before, try doing something a bit different and very enjoyable.....river cruising! The cost is different than rental cars where you have to pay for petrol, the

car, hotels where you stay, meals and snacks, and yes, some extra insurance from your private car at home (a choice you can buy or decline).

River cruises exist with a couple different companies and along most of the bigger rivers in Europe, with obviously different prices between the companies, so get on the computer and request info from all of them (knowing that just that one request for "info" will put you on their list to send you more advertising every week.....if your computer will allow it, make those ads go to "suspect mail" or junk-mail that you can delete by just looking at the company sending). There are river cruises on the main rivers in France and Germany and a few that extend into the Budapest and also to the Black Sea, so there are many to choose from. Having recently been on a Viking cruise from Amsterdam to Switzerland, we found it was just an outstanding way to see Germany from the Rhine ...maybe just a bit higher than a couple of other river cruise companies, but worth every drachma (now Euro). All meals are included in the initial price. There are snacks available 24hrs at two other places on the ship (including your room, if requested along with your own coffee-pot there) and the snacks are delivered by waiters wherever you're sitting on the boat-deck or top-deck alongside the pool or running areas...in fact, those waiters learn early on what your favorite drink is and always ask if you'd like that drink to go with your snack/sandwich, while you continue to watch the countryside passing by...or you stop at one of the many friendly towns/villages along the river where you're able to go ashore and visit the town or castle or nearby shopping area.



## LT Walter G. Cronise, Jr., USN RET

April 14, 1924 to Sept. 20, 2014

Walter Garfield Cronise, Jr. (90) died peacefully on Saturday, September

20, 2014, in Jacksonville, FL. He was born in Baltimore, MD on April 14, 1924, to Walter Garfield and Margaret Catharine (Wunderlich) Cronise and was baptized in the Lutheran church. He was confirmed on April 10, 1938 at Emmanuel Evangelical Church, Baltimore, MD. Walter married the love of his life, Dorothy Mae Nielsen, on May 30, 1944 in Miami, FL. They were blessed with five children, seven granddaughters, and fourteen great-grandchildren.

Walter remained in Baltimore until the age of 17 when he joined the US Navy on December 8, 1941, following the bombing of Pearl Harbor. During his time in the Navy he was trained as a Meteorologist and served three tours of duty with the Hurricane Hunter Squadron. Walter was proud to have served his country for 25 years, including three wars – World War II, Korean War, and Viet Nam War. While stationed primarily in Jacksonville, FL, the Navy also took him to South Florida, Alabama, California, Rhode Island, and Puerto Rico. He considered his assignment as an underway watch officer on an aircraft carrier to be one of his greatest achievements.



He went home took a couple of aspirin and finally called 911 for assistance. He was taken to the hospital and diagnosed with an aneurism. Probabilities were low that he would survive any surgery. In the meantime, he developed a bowel obstruction and required emergency colon surgery. The combination of the two problems weakened his system and he developed a touch of pneumonia. His system was not strong enough to overcome these problems. George passed away early October 3, 2014. He was 93 years old.

#### Lieutenant George F. Buie United States Navy – Retired

LT George F. Buie became an Aerographer Mate Striker in December 1939 and has been in the Navy Weather Service Community for over 71 years. He was born in Greenwood, MS on July 17, 1921, enlisted in the Navy at New Orleans, LA on October 04, 1939 and left immediately for Boot Camp at Norfolk, VA. During his time on active duty, the United States was involved in

WWII, the Berlin Crisis, the Korean Conflict, the Vietnam Conflict and the Cold War Era. When discussing his awards, his comment was SURVIVAL, and that was good enough. He reminisced about being on his honeymoon in Mississippi when the Japanese bombed Pearl Harbor and concern that all his uniforms were in Jacksonville, FL; also when the Saratoga (CV-3) was a target ship during the atomic test at Bikini, Island.

His first assignment was to the USS Ranger (CV-4) at Norfolk, VA as a Blue Shirt (Plane Pusher) in V-3 Division. The berthing compartment was shared with personnel from OA and OP Divisions. After talking with the sailors from OA Division, he requested a transfer to the Weather Office and become an AG Striker. George received orders to Lakehurst, NJ to attend AG "A" School as a member of Class 4019 from August 01, 1940 to October 26, 1940. As the class honor student, he was allowed to pick his assignment to NAS Jacksonville, FL and was the first Aerographers Mate to report for duty. During most of WWII, his assignments were in the USS Massachusetts (BB39) and the USS Saratoga (CV-3).

George was advanced to Chief Petty Officer while serving in the USS Saratoga and after the war; he attended the AERM School, Class C-1 during 1947 at Lakehurst, NJ for those personnel that were promoted to Chief Petty Officer before they attended the advanced "B" school for aerographers. Some of his assignments as a Chief Petty Officer included that of Leading Chief, FWC Morocco, Chief Petty Officer in Charge, NS Trinidad, and as the Aerographers Mate Detailer. As a Warrant Officer, he had assignments to FWC Pearl Harbor, FWC San Diego, FWC Balboa, and at ASO Philadelphia. During September 1960, he was accepted to the METLO Program, attended EMO School in Chicago, IL and was then assigned to FWC Morocco as a METLO until March 1964. When the FWC moved to Spain, George was transferred to ASO Philadelphia and served there until December 1965. His final assignment was to the Office of the Naval Weather Service, Washington, DC. He retired from active duty with 27 years and 08 months service on June 01, 1967.

George and Ms. Francis (Brabham) Buie were married on February 05, 1941 at NAS Jacksonville, FL. She was a resident of Orange Park, Fl. After his retirement they returned to Jacksonville, FL for a couple of years before making their final move to the Advent Christian Village in Dowling Park, FL. For several years they served as house parents and counselors for teenagers, they then purchased a home and hung out their shingle "DUN ROMIN"

## Congressman: New Threats Could Halt Military Cuts

NEWPORT NEWS -- The second-in-command of the House Armed Services Committee predicted Friday that the automatic defense cuts set to begin again next fall will be stopped because rising threats worldwide are swaying Americans to support a stronger military.

U.S. Rep. Mac Thornberry, a Texas Republican, toured Newport News Shipbuilding with four local congressmen. He said afterward that he expects that the remainder of more than \$500 billion in defense cuts set to be made over a decade -- known as sequestration -- will be changed or undone by late next year. The reductions are part of more than \$1 trillion in automatic cuts begun last year. Hampton Roads' economy, which relies heavily on defense spending, has already felt the effects.

"I can't give you the road map on exactly how that will be changed but I do know that as I travel around the country... people realize it's a dangerous world," said Thornberry, who might be in line to become committee

chairman in January. "You just have to summarize the headlines any particular day to know that it is foolhardy to continue to cut defense. I think everybody understands that better now."

He and other members of Congress return to Washington next week and will seek to pass a short-term spending bill, known as a continuing resolution, to keep the government open when the new fiscal year begins Oct. 1. The resolution would continue paying for defense-related programs without interruption.

However, a full annual budget isn't expected to be considered until after the Nov. 4 congressional elections.

Thornberry and members of the region's delegation weren't ready to say whether or when the U.S. should put troops on the ground to deal with threats such as Islamist extremists in Iraq and Syria. But they contended that by its presence, a large U.S. military can deter such threats from rising.

"There may be differences of opinion about the use of military power to deal with any one of those threats," Thornberry said. "But there should be no difference of opinion about having the military power available to deal with this broad array of threats."

U.S. Rep. Randy Forbes, a frequent critic of President Barack Obama's defense policies, noted that Russia's actions in Ukraine and China's pressure on other countries have come at a time when the United States' military is shrinking.

"You don't need Americans at war; you need Americans in leadership," said the Chesapeake Republican, who also is on the armed services panel.

U.S. Rep. Bobby Scott reiterated his argument that building up the military requires new revenue. He has opposed cutting other government programs to shift more money to defense and was critical of Congress's decision last year to renew what's called the Bush tax cuts that were due to expire.

"You can't get this kind of (military) presence free," said the Newport News Democrat. "You need to put this money in the budget. When you spend all your money cutting taxes, you don't have any money left for defense. We need to figure out a way to get some more revenue on the table."


